### ***AIC at Tirupati on February 2 – 3, 2016***

The earlier dates for the 2<sup>nd</sup> triennial All India Conference at Tirupati on 8 – 9 December, 2015 had to be changed as the Reception Committee could not get the venue and accommodation on these dates due to some important festival at Tirupati. Now the Reception Committee has already booked the venue and accommodation for 2 – 3, February, 2016 and as such the All India Conference will be now held on these dates. The Central Executive Committee meeting will be held at 4 PM on 01.02.2016.

Delegates were allotted to the circles as follows:

Kerala – 100, Andhra Pradesh & Telangana – 100, Tamil Nadu – 70, West Bengal – 50, Karnataka – 50, Kolkata – 30, Chennai – 10, Kolkata Telecom Factory & Stores – 5, Assam – 20, NE-I – 5, NE-II – 5, Himachal Pradesh – 5, Haryana – 5, Punjab – 5, NTR – 3, J&K – 3, Jharkhand – 2, Bihar – 5, Odisha – 5, Rajasthan – 20, Gujarat – 20, Maharashtra – 20, Madhya Pradesh – 20, Chhattisgarh – 10, UP (East) – 15, UP (West) – 15, BSNL Pensioners' Welfare Association, Ambala – 5 and CORTO – 10.

The circles may distribute their allotted number of delegates to the districts as per the quota received for the last three years. Any addition to this quota could be admitted as visitors but with prior permission of the Reception Committee. Meanwhile, those who want separate accommodation, particularly for families, can book the rooms on line with the Tirupati Devasthan at their website, [tirumala.org](http://tirumala.org). However, the total number of delegates from each circle and the actual number for whom accommodation is required be intimated to the Reception Committee and CHQ as well.

#### **Circle Conference.**

Tele Pensioner July – September, 2015 issue was dispatched during the last week of September. As already intimated Tele Pensioner has not been sent to those whose subscription period expired. Barring a few district branches, no earnest efforts are taken to enroll new subscribers and renewal of expired subscriptions. Complaints of non receipts be intimated to CHQ and if found existing subscriber, another copy will be sent.

#### **General Secretary at CHQ.**

Com. K.G. Jayaraj, General Secretary who joined CHQ on 7<sup>th</sup> September, 2015 will return to Alappuzha on 02.11.2015.

#### **78.2% IDA merger.**

Despite our continued efforts and agitations, the issue still remains unsettled. Of late when we met the Member (Finance) on 20.10.2015 it was stated that the Cabinet note is being finalized

with the clarifications sought by the Department of Expenditure. CHQ has written to the Prime Minister and Communications Minister on 11.09.2015, copy of which was given to Finance Minister and Communications Minister as well, seeking their intervention. We shall continue to pursue the issue and the Forum of BSNL Unions / Associations is also seriously pursuing the case. In case of any further delay we have to think about further agitational programmes.

***Restoration of Medical Allowance.***

There was some initiative from BSNL, after our concerted efforts and all the employees organizations given their consent to restore the quarterly medical allowance to the retirees, asked circles for certain data some six months ago. Thereafter, there has been no progress and CHQ is again pursuing the case with CMD, BSNL along with extension of broadband concession to DoT Pensioners and reduction of rent for BSNL quarters allotted to BSNL/DoT pensioners.


***7<sup>th</sup> Pay Commission.***

The 7<sup>th</sup> Pay Commission was expected to submit its report by 30<sup>th</sup> September, 2015. But the government has extended the tenure of the Pay Commission by 4 months, i.e. upto 31.12.2015. Therefore, submission of report is unnecessarily been delayed. The Central Government employees Joint Action Committee has decided to observe 'Protest Day' on 19.11.2015, for early submission of Pay Commission report and an indefinite strike is also planned in February, 2016. AIBDPA units are requested to support and participate in these programmes.
