Sub: - **Unjustified and undue delay by circles in sending the cases for 78.2% IDA fixation to the concerned CCAs - req.**

I am every much constrained to bring to your kind notice our serious concern on the unwarranted and undue delay in sending the cases of 78.2% IDA fixation by the BSNL circles to the concerned CCAs.

Issuing revised PPO orders was to be completed by 31.12.2016 as per the original orders. However, the target dates were revised as per the letter referred to (1) above as, 31.03.2017 and 10.04.2017. Even after two months of the revised target date, the situation continues to be unsatisfactory. This association has taken up the issue with the Member (Finance) for early settlement of the cases. And as per the status report provided by DoT, 12,032 cases are still pending to be sent to CCAs. Some circles like Delhi, Andhra Pradesh, Kolkata Telephones, Maharashtra, West Bengal, Rajasthan have paid scant respect, it seems, to the above referred letter (2) of the Corporate Office.

Sir, the pensioners have waited for 4 years to get the benefit their counterparts, retired after 10.06.2013, got it. Naturally they have become restive and agitating and some of them have already passed away without availing the benefits.

So, I would request your personal intervention in the matter so that the circles are made to send the entire cases without further delay.
