Sub: - **Notice for agitational programme on Pension Revision to BSNL retirees with effect from 01.01.2017 with 15% fitment based on 3<sup>rd</sup> PRC recommendations which is approved by the government - reg.**

The Central Executive Committee meeting of AIBDPA held at New Delhi on 25.10.2017 reviewed the developments taken place in the recent past in respect of wage revision and pension revision. The CEC unanimously decided to launch the under mentioned agitational programmes on the following demands:-

- 1) **Revise the Pension of all BSNL retirees with 15% fitment on IDA pattern with effect from 01.01.2017 as affordability condition is not applicable for BSNL pensioners.**
- 2) **Grant a uniform Fixed Medical allowance of Rs. 2,000/- to BSNL retirees as in the case of EPF pensioners.**
- 3) **Immediate pension revision of DOT retirees on option 3 as per order dated 12.05.2017 as the process is not even started in most of the circles even after 5 months of issue of orders.**
