  - h) Grant of notional increment for pension for those completed one year but retire without drawing the increment.
  - i) Grant of pension, gratuity, commutation and leave encashment based on 78.2% IDA fixation w.e.f. 01.01.2017 to those retired between 01.01.2007 to 09.06.2013.
  - j) Monthly medical allowance of Rs.2,000/- and BSNL MRS issues.
  - k) Denial of one extra increment granted in lieu of Gr.IV promotion for 78.2% IDA fixation.
- 6) Protection of BSNL – Separate Tower Company and united struggles.
- 7) NCCPA – Review of Dharna on 25.10.2017, news letter.
- 8) Other items, if any, with the permission of the chair.

The meeting will start with an open session at 10 AM on 30.07.2017 and is scheduled to conclude at 04:00 PM on 31.07.2018.
