Sub: - Reduction in Outdoor ceiling for BSNL employees retired prior to 01-01-2007- req

Ref: - (1) Your office order No.BSNL/Admin-1/14-2/09 dated 08-09-2010.

(2) DGM (CA&ERP FICO) of CGMT office, Rajasthan Circle letter No.AO/ERP-PAYROLL/Misc.Corr/CH-II/2018-19/2 dated 09-04-2018 addressed to AGM (Admin-1) BSNLCO, New Delhi.

(3) Reminder II from DGM(CA &ERP-FICO, CGMT Office, Jaipur, Rajasthan No.AO/ERP-PAYROLL/Misc-Corr/CH-II/2018-19/15 dated 04-08-2018.

It has been brought to the notice of this Association that despite several letters fro Circle Office, Rajasthan and reminders thereof a genuine issue is pending unresolved at Corporate office level.

As per office order referred to (1) above, the employees retired prior to 2007 are given two options for claiming medical reimbursement with voucher. According to the option No.2, the ceiling will be limited to 25 days basic pay drawn at the time of retirement and IDA applicable for the month of April of the financial year for which the claim pertains to.

But it is reported that due to non-circulation of the revised rate of IDA on the pay scales of 1st PRC, ie on link point 1708 (as on 01-01-1997) by the BSNL Corporate Office, New Delhi, updating of the revised and correct IDA is not being done in ERP-HCM. As a result, all the pre 2007 retirees are deprived of their due and eligible amount of medical claims.

As you are aware, there is a great discrimination between the pre 2007 and post 2007 retirees due to the unscientific criteria in the BSNL MRS. And therefore this will be nothing but adding insult to injury to these section of retirees.

I would therefore request your kind intervention in the matter to settle the issue without further delay.
