Sub: - **Non-drawal of pension without any valid reason & Non-functioning of CCA office, Aurangabad, Maharashtra - req.**

We wish to bring to your kind notice the following issue for early benevolent action.

Many BSNL retirees on superannuation, coming under the jurisdiction of CCA, Aurangabad are not being paid pension since several months mainly due to nonfunctioning of CCA office, Aurangabad. The employees as well as pensioners were much delighted when a CCA office was started at Aurangabad with much fanfare on 17-05-2018. Nine SSAs were brought under the jurisdiction of Aurangabad CCA and naturally retirees hoped speedy settlement of their issues. But the experience has been just the contrary. The CCA office was shut down for months together under the cover of Covid-19 pandemic and heavy downpour etc. Though the cases are transferred to CCA office, Mumbai, there has been no progress. We are appreciative of the repeated orders/instructions for speedy processing of pension cases and timely payment of pension issued by DOP&PW and DoT. Unfortunately, these are not being adhered to by CCA, Mumbai, putting the retirees to utter distress. Some of the cases, pertaining to Aurangabad SSA are appended below for ready reference.
