We are constrained to bring to your kind notice a genuine issue of a family pensioner pending unresolved due to inaction of the Corporate Office.

Complying with your advice, we have instructed our members to switch over from BSNL MRS to CGHS and many pensioners are switching over to CGHS.

The above referred family pensioner also has switched over to CGHS by paying the one-time subscription and submitted her reimbursement claim on 05-12-2019. But the Haryana Telecom Circle raised certain objections and referred the case for clarification to Corporate Office vide letter referred (1) above. As there was no response from the Corporate Office, even after six months, this Association was compelled to intervene and was brought the issue to the notice of GM(Admn), CO vide our letter referred (2) above.

But Sir, still there is no progress and we are compelled to approach you for early settlement of the issue. Sir, we may be permitted to point out that this is nothing but lack of accountability affecting the very credibility of Corporate Office which warrants your effective intervention.
