We wish to bring to your kind notice a serious issue under reference for early intervention please.

Director (staff), Department of Telecommunications vide order No.9-8/2019-Vig,I dated 06-08-2020 has exonerated Shri. K Jayakodi of all the charges leveled against him and treating his suspension period and dismissal period as duty for all purposes with full pay and allowances under provisions of FR 54 B.

CGMT in the letter under reference has sought the approval of Corporate Office to issue the Presidential Order already issued vide PO No.27-1/TN/Vellore/103/2001 dated 01-01-2002 and the official was not absorbed in BSNL due to disciplinary proceedings pending against him.

Meanwhile the official Shri.K Jayakodi has expired on 25-07-2019 and naturally the family is in great financial difficulties due to non-sanction of retirement benefits and family pension.

Therefore, we request your kind intervention for approval of the issuance of Presidential Order as sought by CGMT, Tamil Nadu so that the case is settled without further delay.
