Sub: - **Drawing lesser LPD than juniors due to delayed order of promotion- case of Account Officers of Kerala Circle - request for early settlement - reminder thereof.**

Further to our letter under reference (copy enclosed for ready reference), we once again approach you for a reasonable settlement of the issue referred to above.

We also draw your kind attention to the Reminder-1 sent by CGMT Office, Kerala wide letter referred to (3) above. (copy enclosed for ready reference).

The issue has occurred due to delayed order of TBOP promotion to the Account Officers of Kerala. Their juniors in Karnataka Circle were given the promotions in December whereas they were getting the promotion in April, next year. Thus they did not get the promotion E5 to E6, as the VRS was implemented from 31-01-2020. However, their juniors in Karnataka got the E6 in December, 2019. This anomaly has occurred for no fault of the affected AOs.

This has caused great loss in their Pension and pensionary benefits including ex-gratia.

Sir, therefore it is a genuine issue to be resolved at Corporate Office level.

It is pertinent to point out that the issue is being delayed unnecessarily. Delayed justice is equal to denial of justice. Moreover, Corporate Office is expected to set an example of settling any issue in a time bound manner with accountability.

Hence, we fervently request you to kindly cause necessary action for settlement of the issue without further delay and extend justice to these Account Officers of Kerala.
