The Controller General of Accounts vide the above OM has directed for disbursement of salary and Pension on 19-08-2021 in view of Onam Festival in Kerala and 18-09-2021 in connection with Ganapati Festival in Maharashtra and Goa.

Accordingly, State Bank of India has already drawn the pension to BSNL absorbed pensioners of Kerala on 17-08-2021.

Therefore, kindly arrange to include the restored rate of 170.5% IDA from 01-07-2021 while drawing the pension for August, 2021.

Early action may also be taken to draw the September, 2021 pension on or before 18-09-2021 to BSNL absorbed pensioners of Maharashtra and Goa in view of Ganapati Festival.
