- Sub: <u>Drawing lesser LPD than juniors due to delayed order of promotion- case of Account Officers of Kerala Circle-request for early settlement- reminder 2 thereof.</u>

We would request you to kindly spare five minutes of your valuable time for the resolution of the genuine issue under reference.

As you are aware, the issue is pending for a long time even after three reminders by the CGMT, Kerala. This Association also have taken up the issue having been convinced of the genuineness of the case. We are forwarding herewith the 3rd reminder of CGMT, Kerala addressed to DGM, SEA, BSNL CO for ready reference.

Actually, it is a case of anomaly caused due to the late rather discriminatory orders of promotion to the 1996 batch Account Officers of Kerala. They were given the promotion with effect from 01-04-2001 whereas their juniors in Karnataka were promoted with effect from 01-12-2000. The same was repeated in the subsequent promotions also resulting in denial of E5 to E6 to the Account Officers of Kerala who availed VRS on 31-01-2020. This has caused huge loss to these Account Officers including lesser pension than their juniors in Karnataka who got the promotion from E5 to E6 from 01-12-2019

Hence, we once again request you to kindly cause necessary action for settlement of the issue without further delay and extend justice to these Account Officers of Kerala.
