Meanwhile, the pathetic condition of the poor family of the deceased Regular Mazdoor has aggravated from worse to worst and the poor aged and ailing widow is struggling miserably to pull on each day.

So Sir, it is absolutely necessary to save the family from utter distress without any further delay.

In view of the above facts, it is once again requested to do the needful to accord necessary approval for granting family pension by the competent authority and settle the very long pending issue at the earliest.
