Sub: - <u>Migration of BSNL Pensioners to CGHS- Request for direct payment of one-time payment by BSNL to CGHS-</u> reg.

While persuading BSNL retirees to migrate to CGHS from BSNL MRS, we have met with the following hurdles at the field level.

- Inability to remit the one-time huge amount to CGHS by the individual Pensioners due to financial constraints.
 Therefore, if an arrangement is made to pay the one-time amount of each retiree to CGHS directly by the BSNL, we can assure you that a large number of BSNL Pensioners will switch over to CGHS.
- 2. CGHS related issues.

As you are aware most parts of the country still remains uncovered of CGHS. Even in the few cities covered by CGHS, problems are aplenty.

- a. No sufficient number of empaneled hospitals.
- **b.** Withdrawals of even the limited number of empaneled hospitals due to non-payment of dues in time.
- **c.** Lack of initiative by CGHS for periodical increase in the CGHS rates.

Of course, we have already taken up these issues with the Central Government and CGHS. It is pertinent to point out that when 2.5 lakh BSNL Pensioners switch over to CGHS, BSNL management has a right to bring these important issues to the Central Government to ensure better medical facilities to the migrated BSNL Pensioners.

We sincerely expect a positive approach from your good self and early necessary action in the best interest of BSNL Pensioners and BSNL as well.
